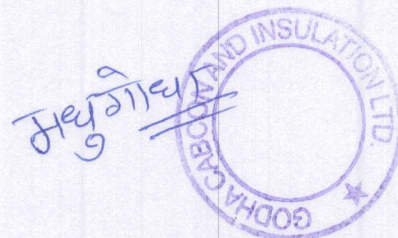

SCRUTINIZER'S REPORT ON POSTAL BALLOT
THROUGH E-VOTING

Dear Sir/Mam,

1. The Board of Director of Godha Cabcon & Insulation Limited (hereinafter referred to as "the Company") has appointed Deepak Patil & Co., Practicing Company Secretary (FCS No. 9636, CP No. 11592) as the Scrutinizer by way of Resolution passed at Board meeting held on August 20, 2020 for the purpose conducting postal ballot through e-voting for following resolution as mentioned in the Postal Ballot Notice dated August 20, 2020:

1.1 Special Business requiring consent of shareholders through Postal Ballot:

Migration of Listing/ Trading of Equity Shares of the Company from SME Platform (EMERGE) of National Stock Exchange of India Limited (NSE) to Main Board of NSE.

2. I submit my report as under:

- 2.1. In view of the current extraordinary circumstances, due to non-availability of postal and courier services, on account of threat posed by COVID-19 pandemic situation and in accordance with General Circular No. 14/2020 dated April 8, 2020 and the General Circular No. 17/2020 dated April 13, 2020 issued by Ministry of Corporate Affairs, Government of India (hereinafter referred to as "the MCA Circular"), the Company has sent the Postal Ballot Notice in electronic form only and expressed its inability to dispatch hard copy of Postal Ballot Notice along with Postal Ballot Form and pre-paid business reply envelope to the shareholders for this Postal Ballot. Accordingly, the communication of the assent or dissent of the members took place through the remote e-voting system only.



- 2.2. On August 28, 2020, the Company has completed the dispatch of Postal Ballot Notice electronically to those shareholders who have registered email id with their depositories and whose names appear on the Register of Members/records of Depositories as at the close of business hours on Friday, August 21, 2020 i.e. the cut-off date.
- 2.3 The Company has availed E-voting facility offered by Karvy Computershare Private Limited for providing the E-Voting Platform for conducting E-voting for the shareholders of the Company and the Remote E-voting period remained open from 29th August, 2020 (09.00 A.M.) to 27th September, 2020 (05.00 P.M.) and the Karvy E-voting platform was blocked thereafter.
- 2.4 Particulars of all electronic votes received from the Members have been entered in an electronic register separately maintained for the purpose.
- 2.5 Total 17 Shareholders have voted during this postal ballot event out of which all 171 shareholders voted through e-voting.
- 2.6 The votes cast under e-voting were unblocked at Indore on Sunday, September 27, 2020 by CS Deepak Patil, Scrutinizer.
- 2.7 The Postal Ballot electronic votes were duly scrutinized and the shareholding was matched / confirmed with the Register of members of the Company as on Friday, August 21, 2020, (Cut-off date) provided by KFin Technologies Private Limited, the Registrar and Share Transfer Agent of the Company.
- 2.8 The soft copy of list of equity shareholders who voted "FOR" and "AGAINST" and those whose votes were declared Invalid/Abstain/Less Voted for resolution are shared with the Company vide email dated September 28, 2020.
